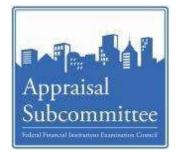

# Appraisal Standards Board (ASB)

- Related to the development, interpretation, amendment or advancement of the Uniform Standards of Professional Appraisal Practice (USPAP) associated with federally related transactions, or special projects related thereto
- Included in the annual approved grant award budget

### Appraiser Qualifications Board (AQB)

- Related to the:
  - o development, interpretation, amendment or advancement of the Real Property Appraiser Qualification Criteria (AQB Criteria), or special projects related thereto; or
  - o maintenance of the National Uniform Examination
- Included in the annual approved grant award budget

### Board of Trustees (BOT)

 Related to grant-eligible activities of the ASB or AQB (e.g., expenses associated with the Oversight Committee of the BOT may be eligible for reimbursement if directly related to oversight of the ASB or AQB's grant eligible activities) Staff approved total payments amounting to \$115,057 as requested by the Foundation for October 2015 through January 2016 activities. The total grant budget is \$659,632 and \$544,575 remains.
