This letter is in response to your August 15, 2005 correspondence requesting information in regard to the choice to be exercised by each of the seven appraisers identified by the Appraisal Subcommittee (ASC) as not having taken and passed an acceptable qualifications examination.

[DELETED] [DELETED] sent a request for reconsideration due to a clerical error by our office. [DELETED] case has not been previously considered by the ASC. [DELETED] passed the residential examination on May 17, 2002. The exam results were mailed to [DELETED], Missouri_ He submitted his experience log on January 8, 2004, along with a change of address. Work samples were requested on January 12, 2004. The request was sent to his new address, [DELETED], Missouri. At the April 7 & 8, 2004 Commission meeting, the Commission approved [DELETED] for certification. A letter was sent to him dated April 13, 2004, advising him that he had been approved for the [DELETED] designation, however, the letter was erroneously sent to his previous address in [DELETED], Missouri. The letter was returned to this office as "Forward Time Expired". For some unknown reason, the letter was not immediately resent to the correct address. By the time the error was discovered, [DELETED] two year time frame had already elapsed. [DELETED] was issued his certificate on [DELETED], 2004. Please advise as to how you would like to proceed with this request.
