RE: ASC Compliance Review of Illinois' Appraisal Management Company (AMC) Regulatory Program

Dear Laurie Murphy:

The Appraisal Subcommittee (ASC) staff conducted an ASC Compliance Review (Review) of the Illinois AMC regulatory program (AMC Program) on October 30 through November 3, 2023, to determine the AMC Program's compliance with Title XI of the Financial Institutions Reform, Recovery, and Enforcement Act of 1989.

The ASC considered the preliminary results of the Review and the State's response to those results. The AMC Program has been awarded an ASC Finding of "Good." The final ASC Compliance Review Report (Report) is attached.

The ASC identified the following areas of non-compliance:

- States must impose requirements on State-registered AMCs to direct the appraiser to perform the assignment in accordance with USPAP;¹ and
- States must determine whether State registered AMCs meet the federal definition of an AMC to be eligible to be on the AMC Registry and if eligible, collect and transmit the registry fees.²

ASC staff will confirm that appropriate corrective actions have been taken during the next Review. Illinois will remain on a two-year Review Cycle.
