RE: ASC Compliance Review of Michigan's Appraisal Management Company (AMC) Regulatory Program

Dear Amy Gumbrecht and Bryan Modelski:

The Appraisal Subcommittee (ASC) staff conducted an ASC Compliance Review (Review) of the Michigan AMC regulatory program (AMC Program) on July 11–13, 2023, to determine the AMC Program's compliance with Title XI of the Financial Institutions Reform, Recovery, and Enforcement Act of 1989.

The ASC considered the preliminary results of the Review and the State's response to those results. The AMC Program has been awarded an ASC Finding of "Good." The final ASC Compliance Review Report (Report) is attached.

The ASC identified the following areas of non-compliance:

- States must determine whether State registered AMCs meet the federal definition of an AMC to be eligible to be on the AMC Registry and if eligible, collect the registry fee; and
- States must ensure the accuracy of all data submitted to the AMC Registry.²

ASC staff will confirm that appropriate corrective actions have been taken during the next Review. Michigan will remain on a two-year Review Cycle.
