<OPEN SESSION>

1. Opening Remarks

- P. Gillispie welcomed the observers to the Meeting. He noted the Appraisal Complaint National Hotline website will be demonstrated in the Open Session.
- J. Park reported on monthly staff activities. He attended the Appraisal Standards Board (ASB) meeting in San Francisco, CA. The ASB voted to adopt several changes to the Uniform Standards of Professional Appraisal Practice for the 2014-15 edition. The Financial Manager vacancy announcement closed on February 1st. The Office of Personnel Management is reviewing the applications and will provide ASC staff with a list of qualified candidates this Friday.

2. Summary Agenda

• January 23, 2013 minutes - Open Session

D. Eberley made a motion to approve the January 23rd open session meeting minutes as presented. A. Lindo seconded and all members present voted to approve.

3. Discussion Agenda

• Appraisal Complaint National Hotline (Hotline)

J. Park updated the Board and observers on the implementation of the Hotline. The purpose of the Hotline is to refer complainants to the appropriate legal authorities to investigate their complaint. ASC staff has been working with ASC member agencies to develop the Hotline. The implementation plan was approved by the ASC in open session at its January 23rd Meeting. N. Fenochietti gave a brief demonstration of the Hotline website and also described the process if a complainant contacts the call center.

• Missouri Compliance Review

D. Graves presented the Missouri Compliance Review. Missouri was found to be not in substantial compliance with Title XI. ASC staff recommends retaining Missouri on a two-year Review Cycle with a Follow-up Review in six months. D.

Benhart moved to approve the Missouri Compliance Review and letter. S. Cooper seconded and all members present voted to approve.
