### • September 27, 2012 minutes – Open Session

M. Marshall made a motion to approve the September 27<sup>th</sup> open session meeting minutes with edits. A. Lindo seconded and all members present voted to approve.

## 3. Discussion Agenda

### Appraisal Foundation July 2012 Grant Reimbursement Request

J. Park presented the Appraisal Foundation's July 2012 grant reimbursement request in the amount of \$88,690. The majority of this request covers an ASB meeting and work session held in Denver, CO and a Subject Matter Expert meeting in Tampa, FL. A. Lindo noted the ASB is nearing their grant ceiling and asked if they would be requesting any substantial amounts in either the August or September reimbursement. J. Park responded they may but it should be within the amount approved in the grant. A. Lindo moved to approve the request in the amount of \$88,690. D. Benhart seconded and all members present voted to approve.

#### Alabama Compliance Review

D. Graves presented the Alabama Compliance Review. Alabama was found to be not in substantial compliance with Title XI. ASC staff recommends leaving Alabama on a two-year Review Cycle with a Follow-up Review in 6-9 months.

### • Louisiana Compliance Review

D. Graves presented the Louisiana Compliance Review. Louisiana was found to be not in substantial compliance with Title XI. ASC staff recommends leaving Louisiana on a two-year Review Cycle with a Follow-up Review in May 2013.

### • Michigan Compliance Review

D. Graves presented the Michigan Compliance Review. Michigan was found to be not in substantial compliance with Title XI. ASC staff recommends leaving Michigan on a two-year Review Cycle with continued off-site monitoring.

### New Jersey Compliance Review

D. Graves presented the New Jersey Compliance Review. New Jersey was found to be not in substantial compliance with Title XI. ASC staff recommends leaving New Jersey on a two-year Review Cycle with a Follow-up Review in one year.

### • Texas Compliance Review

D. Graves presented the Texas Compliance Review. Texas was found to be not in substantial compliance with Title XI. ASC staff recommends leaving Texas on a two-year Review Cycle with continued off-site monitoring.

# • Washington Compliance Review

D. Graves presented the Washington Compliance Review. Washington was found to be not in substantial compliance with Title XI. ASC staff recommends leaving Washington on a two-year Review Cycle with continued off-site monitoring.

D. Eberley moved to approve all of the Compliance Reviews as discussed. D. Benhart seconded and all members present voted to approve.
